The State of Texas to the Sheriff of Travis County: Greeting.

WHEREAS, The State of Texas, On the 25 day of Oct in the Year of Our Lord One Thousand Eight Hundred and 72, at our District Court, then in session at the City of Austin, within and for the County and State aforesaid, hath recovered a judgment against Billy Thompson for the sum of 15 Dollars, fine imposed by virtue of a criminal prosecution and the verdict of a jury, together with all costs of said prosecution, as per bill herunto annexed, and which to the said State of Texas were adjudged.

And Whereas, Thereafter, at said term of said Court aforesaid, on the 18 day of personally appeared in open Court, and acknowledged bound for the payment of the fine and costs aforesaid, in accordance with Article Six Hundred and Ninety-three of the "Code of Criminal Procedure," whereby said securities became liable, in judgment, for the payment of said fine and costs, all of which appears to us of record as aforesaid; and whereas,

WHEREFORE, We command you, that you take the body of the Goods and Chattels, Lands, Tenements and Estate of the said Billy Thompson and hold him in custody until he pay you cause to be made the aforesaid sum of 15 Dollars, fine imposed as aforesaid, and also, the said further sum of 30 & 63/100 Dollars, costs, as aforesaid, together with the costs of this execution, and your legal fees accruing in said matter.

HEREIN FAIL NOT, But make due return of this execution to our said District Court, on or before the first day of the next term thereof, with your return thereon endorsed how you have executed the same
